As you already know, this year in geography is "Year of Poland". There are two consecutive events organized by the Commission. The Commission 2014 annual conference will be held in Poznan (Poland) on 14-16 August 2014. We will be hosted by our colleagues from Adam Mickiewicz University (AMU). The conference will be organised under main theme - "New challenges in local, metropolitan and regional governance".

After this meeting we will move from Poznan to Krakow, the place of IGU Regional Conference. IGU Regional Conference with headline - "Changes, Challenges, Responsibility", will be held on 18-22 August 2014 at Jagiellonian University.

FORTHCOMING ACTIVITIES IN 2015 AND 2016

There are two Commission events planned for 2015. We will have our annual conference in Lisbon in Spring 2015, and we will participate on IGU Regional Conference in Moscow during Summer 2015.

The 2015 Annual Conference of the IGU Commission on 'Geography of Governance'

The 2015 Annual Conference of the IGU Commission on 'Geography of Governance' will address the theme "Local Government and Urban Governance: Citizen Responsive Innovation in Europe and Africa". The Conference will be organized by Professor Carlos Nunes Silva, Institute of Geography and Spatial Planning, University of Lisbon, Portugal. It will be held **in Lisbon, 9-10 April 2015**. Further information will be available soon at the conference website (https://sites.google.com/site/locgovgeo2015/home), Commission website, as well as by special calls distributed to corresponding members by e-mail and Commission Newsletter.

IGU Regional Conference in Moscow

We also plan to have sessions within IGU 2015 Regional Conference, which will be held in Moscow in August 2015. It will be organized by Russian Geographical Society, Russian Academy of Science and Lomonosov Moscow State University - Faculty of Geography. It will take place at the main campus of Moscow State University, well-known tower building situated in a park above the Moscow River.

Conference registration begins on 1 November 2014. To register, it will be necessary to create a personal account in the online registration system. There are different fees

announced, depending on time of registration. Early registration is valid from 1 November 2014 to 10 April 2015, standard registration is applicable since 11 April 2015 to 10 June 2015. Please be aware that participants in the oral and poster presentations during the commission sessions, general sessions and joint sessions must complete their registration and payment up to 31 January 2015. Early registration fees are 399 USD, or 199 USD for students.
