COMMISSION ANNUAL CONFERENCE IN LISBON 2015

The 2015 Annual Conference of the IGU Commission on 'Geography of Governance' addressed the theme "Local Government and Urban Governance: Citizen Responsive Innovation in Europe and Africa". The Conference was organized by Professor Carlos Nunes Silva, Institute of Geography and Spatial Planning, University of Lisbon, Portugal. It was held in Lisbon, 9-10 April 2015.

The conference has very good response among the scholars around the world. Initially, we obtained more than 100 abstracts that went through review process. Finally, we registered more than 70 participants from 25 countries. Final programme consisted of two planetary sessions, and set of parallel panel sessions around issues of governance in Europe, urban governance in Africa and ICT in urban governance. We could listen and discuss almost seventy very interesting contributions prepared by participants working in various scientific disciplines. As follow up, conference organizers consider publication of selected conference contributions in journal special issues and in scientific monograph.

On behalf of conference participants as well as the Commission, I would like to express our great thanks to Carlos N. Silva for his long term effort in preparation of this conference. It was not easy task to manage conference in this scale. Our Commission meetings in Lisbon are already becoming famous thank to perfect organization, as well as high scientific standard. We are also grateful to all support staff and students involved in conference preparation and services.
